5	WHEREAS, in accordance with Section 507(b) of the Cecil County Charter, on June 6, 2023, the Budget		
6	for Cecil County was adopted for Fiscal Year 2024; and		
7	WHEREAS, the County Executive is revising the Fiscal Year 2024 Community Services Grants Fund –		
8	Department of Community Services – Human Services Division, Fund 109, Department 533, revenue estimate for		
9	Cecil County to establish the following amount: the addition of \$278,976 in grant revenue and expense to the		
10	Community Services Grants Fund – Department of Community Services budget to provide for a grant from the		
11	Maryland Governor's Office of Crime Prevention, Youth, and Victim Services; and		
12	WHEREAS, such appropriation is necessary to provide \$278,976 in grant funding to provide contractual		
13	services, equipment, supplies, operational and staffing support to victims of domestic violence and sexual		
14	assault.

18	additional expenditures in the Community Services Grants Fund – Department of Community Services, Fund 109,		
19	Department 533, to record the grant awarded from the Maryland Governor's Office of Crime Prevention, Youth,		
20	and Victim Services.
