1	WHEREAS, in accordance with Section 505 of the Cecil County Charter, on April 1, 2023, the		
2	County Executive submitted a proposed budget to the County Council for Fiscal Year 2024; and		
3	WHEREAS, in accordance with Section 506 of the Cecil County Charter, the County Council held		
4	public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2024; and		
5	WHEREAS, in accordance with Section 507(b) of the Cecil County Charter, on June 6, 2023, the		
6	Budget for Cecil County was adopted for Fiscal Year 2024; and		
7	WHEREAS, the County Executive is revising the Fiscal Year 2024 revenue estimate for Cecil County		
8	to increase the use of the Assigned Fund Balance for Cecil County Public Schools by \$410,595.75, in order		
9	to allow the following appropriation within the General Fund: the addition of \$410,595.75 in		
10	expenditures for incomplete FY2023 Construction Pay Go Funds (Small Capital Projects). On June 30,		
11	2023, there were several projects that were not completed and need the remaining FY2023 budget		
12	available to finish the project. The incomplete projects are as follows: safe and secure entrances at		
13	Bainbridge Elementary, Charlestown Elementary, and North East Elementary Schools; and		
14	WHEREAS, such appropriation is necessary to provide \$410,595.75 of the County Executive's		
15	FY2023 assigned fund balance for the General Fund for expenditures.		
16	NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,		
17	MARYLAND, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for Fiscal		
18	Year 2024 is hereby amended for the supplemental appropriation; and by amending the Current Budget		
19	to appropriate \$410,595.75 of additional expenditures, in the General Fund, in order to fund Cecil County		
20	Public Schools Construction Pay Go Funds (Small Capital Projects).		
21	AND, BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, that		
22	this Resolution shall take effect on the date of its passage.
