CALL TO ORDER

The meeting of the County Council of Cecil County of August 1, 2023, was called to order by Council President Gregory at 8:00 p.m.

MOMENT OF SILENCE

President Gregory asked for a moment of silence.

APPROVAL OF AGENDA

On motion made by Vice President Meffley, seconded by Councilwoman Culberson, the Council moved to approve the legislative agenda of August 1, 2023. The motion was approved unanimously.

APPROVAL OF MINUTES

On motion made by Councilwoman Culberson, seconded by Vice President Meffley, the Council moved to approve the minutes of the legislative session of July 18, 2023. The motion was approved unanimously.

Sean Brimm of Elkton spoke on child abuse. Phyllis Kilby of Colora spoke on the need for weed control.

President Gregory noted that Council comments were given at the Work Session on August 1, 2023.

Councilwoman Hamilton noted that the Elkton Music Hall Ribbon cutting is on August 4 at 7:00 pm.

Director of Administration Steven Overbay noted that the new bids were received and the revised numbers were sent to Council for the amendment to the resolution.

A Resolution to approve a five (5) year agreement between the County on behalf of the Cecil County Sheriff's Office and Axon Enterprise, Inc. for the acquisition of Sixty-five (65) Taser 10 Inert Magazine Red with two spares, Inert Unitary Cartridge, Taser 10 Blackhawk Holster RH, Enhanced Hook-and-Loop Training (halt) Suit V2, Target Frame Professional 27.5 in X 75 in, Certification Bundle. The bundle includes all training cartridges, unlimited duty cartridges, and instructor training vouchers.

Introduced, read for the first time, order posted on July 18, 2023 and scheduled for consideration on August 1, 2023.

Director of Administration Steven Overbay noted that this was a 5-year contract for the tasers. Director Overbay noted that these tasers will be for correctional officers and will be an upgrade.
