WHEREAS, the Economic Development Commission was created to advance the general economic welfare of the people through the establishment of programs and activities that result in new economic activity, job growth, and expansion of the local tax base, and that relate to manufacturing, distribution, research and development, corporate and regional offices, agriculture, and tourism; and to cooperate with and offer assistance to existing industries and businesses in order to facilitate economic expansion, and to promote and encourage the establishment and location of new industries and businesses in Cecil County; and to develop and implement workforce development initiatives intended to foster and develop gainful employment opportunities for all who are now or may hereafter be residents of Cecil County, pursuant to Section 16-1. Creation, Chapter 16. Boards, Committees and Commissions; Part I. Administrative Legislation in the Code of Cecil County; and

WHEREAS, the Economic Development Commission is composed of not fewer than 23 nor more than 33 members who should reasonably represent the various sectors within Cecil County and shall be selected because of their known experience and interest in the economic development of Cecil County, pursuant to Section 16-2. Membership, and

WHEREAS, members of the Commission shall serve for three years from the effective date of their appointment and are eligible for reappointment, pursuant to Section 16-3. Term of office, and

WHEREAS, the Economic Development Commission shall make an annual report to the County within 90 days of the end of the fiscal year that shall assess the performance of the Commission and staff and make recommendations for the improvement and advancement of the economic welfare of the people of Cecil County, pursuant to Section 16-5. Annual Report; and

WHEREAS, Article 4, Section 412 (b) of the Charter of Cecil County provides, except as provided on Section 412(c) or prescribed by State law or other provisions, that the County Executive shall appoint all members of boards and commissions, subject to confirmation by the Council; and

WHEREAS, the County Executive has recommended Amy Marston for appointment to the Economic Development Commission, to finish the term of Sharon Kurfuerst, which is to expire on January 17, 2026, and Kristina Brown to finish the term of Jeffrey Emmons, which is to expire on April 1, 2025.

NOW, THEREFORE, BE IT HEREBY RESOLVED THAT THE COUNTY COUNCIL OF CECIL COUNTY,

MARYLAND confirms the recommendation by the County Executive of Amy Marston, to a term which is to

expire on January 17, 2026 and Kristina Brown, to a term which is to expire on April 1, 2025.
