RESOLUTION NO. 57-2023

Supplemental Appropriation – Grant Funds – Tourism – Winter Lights Cecil Nights

1 **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2023, the
2 County Executive submitted a proposed budget to the County Council for Fiscal Year 2024; and

3 **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held
4 public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2024; and

5 **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 7, 2023, the
6 Budget for Cecil County was adopted for Fiscal Year 2024; and

7 **WHEREAS**, the County Executive is revising the Fiscal Year 2024 Special Revenue Other Grants
8 Fund – Office of Economic Development revenue estimate for Cecil County to establish the following
9 amount: the addition of \$11,000 in grant revenue and expense to the Special Revenue Other Grants
10 Fund – Office of Economic Development – Tourism budget to provide for the grant from the Upper
11 Shore Regional Council awarded to Cecil County; and

12 **WHEREAS**, such appropriation is necessary to provide \$11,000 in program funding to allow for a
13 “Winter Lights-Cecil Nights” Marketing Campaign designed to promote downtown municipal
14 businesses.

15 **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**
16 **MARYLAND**, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for Fiscal
17 Year ending June 30, 2024 is hereby amended for the supplemental appropriation, and by amending
18 the Current Budget to appropriate \$11,000 in additional expenditures in the Special Revenue Other
19 Grants Fund – Office of Economic Development-Tourism, to record the grant awarded from the Upper
20 Shore Regional Council, for the purpose of a “Winter Lights-Cecil Nights” Marketing Campaign in Cecil
21 County.

22 **AND BE IT FURTHER RESOLVED** that this Resolution shall take effect on the date of its passage
23 by the County Council of Cecil County, Maryland.
