2	County Executive submitted a proposed budget to the County Council for Fiscal Year 2024; and

4	public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2024; and	
5	WHEREAS, in accordance with Section 507(b) of the Cecil County Charter, on June 7, 2023, the	
6	Budget for Cecil County was adopted for Fiscal Year 2024; and	
7	WHEREAS, the County Executive is revising the Fiscal Year 2024 revenue estimate for Cecil Count	
8	to decrease the use of the Unassigned Fund Balance for the Department of Emergency Services by	
9	\$50,000, in order to allow the following appropriation within the General Fund: the addition of \$50,000	
10	to the previously awarded ARPA funds of \$175,000 as approved in FY 2024 County budget for Volunteer	
11	Fire Companies in Cecil County to augment the on-going testing of Fire Hose, Ground Ladders, Aerial	
12	Ladders, Self-Contained Breathing Apparatus (SCBA) and Fire Pumps/Fire Apparatus; and	
13	WHEREAS, such appropriation is necessary to provide \$50,000 from the County Executive's	
14	FY2024 unassigned fund balance for expenditures to augment the on-going testing for the Volunteer Fire	
15	Companies in Cecil County.

19	Current Budget to appropriate \$50,000 of additional expenditures, from the General Fund, in order to	
20	fund Department of Emergency Services, Volunteer Fire Companies in Cecil County for on-going testing.
