**RESOLUTION NO. 60-2023**

**Title of Resolution:** Supplemental Appropriation – Grant Funds – Emergency Services – MDOT Grant - Highway Safety.

**Synopsis:** A Resolution to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland, Department of Emergency Services, Highway Safety Fund, for the fiscal year ending June 30, 2024, in order to provide a total of \$1,643 to the Highway Safety Fund; to record the grant awarded from the Maryland Department of Transportation, Highway Safety Office for two purposes – Purchasing additional Pediatric Patient Restraint devices to transport patient safely in ambulance and to purchase impaired Driving Simulation Goggles for use when engaging the community to encourage the prevention of impaired driving.

**Supplemental Appropriation – Grant Funds – Emergency Services – MDOT Grant - Highway Safety**

1           **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2023, the  
2 County Executive submitted a proposed budget to the County Council for Fiscal Year 2024; and

3           **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held  
4 public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2024; and

5           **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 7, 2023, the  
6 Budget for Cecil County was adopted for Fiscal Year 2024; and

7           **WHEREAS**, the County Executive is revising the Fiscal Year 2024 Department of Emergency  
8 Services, Highway Safety fund revenue estimate for Cecil County to establish the following amount:  
9 the addition of \$1,643 in grant revenue and expense to the Highway Safety Fund, Department of  
10 Emergency Services budget to provide for a grant from the Maryland Department of Transportation  
11 Highway Safety Office; and

12           **WHEREAS**, such appropriation is necessary to provide \$1,643 in grant funding to supplement  
13 efforts in the protection of Pediatric Patients and the reduction of impaired driving in Cecil County.

14           **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**  
15 **MARYLAND**, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for Fiscal  
16 Year ending June 30, 2024 is hereby amended for the supplemental appropriation; and by amending  
17 the current budget to appropriate \$1,643 of additional expenditures in the Department of Emergency  
18 Services to record the grant awarded from the Maryland Department of Transportation, Highway  
19 Safety Office.

20           **AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that  
21 this Resolution shall take effect on the date of its passage by the County Council of Cecil County,  
22 Maryland.
