RESOLUTION NO. 65-2023

Supplemental Appropriation – Grant Funds – Cecil County Liquor Board –
Inspection and Enforcement Activities

1 **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2023, the
2 County Executive submitted a proposed budget to the County Council for Fiscal Year 2024; and

3 **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held
4 public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2024; and

5 **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 7, 2023, the
6 Budget for Cecil County was adopted for Fiscal Year 2024; and

7 **WHEREAS**, the County Executive is revising the Fiscal Year 2024 Special Revenue Other Grants
8 Fund – Cecil County Liquor Board revenue estimate for Cecil County to establish the following
9 amount: the addition of \$12,000 in grant revenue and expense to the Special Revenue Other Grants
10 Fund – Cecil County Liquor Board budget to provide for the grant from the Cecil County Drug-Free
11 Communities Coalition (DFC) awarded to Cecil County; and

12 **WHEREAS**, such appropriation is necessary to provide \$12,000 in program funding to allow for
13 the purpose of supporting inspection and enforcement activities of the Cecil County Liquor Board.

14 **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**
15 **MARYLAND**, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for Fiscal
16 Year 2024 is hereby amended for the supplemental appropriation, and by amending the Current
17 Budget to appropriate \$12,000 in additional expenditures in the Special Revenue Other Grants Fund –
18 Cecil County Liquor Board, to record the grant awarded from the Cecil County Drug-Free Communities
19 Coalition (DFC) the purpose of supporting inspection and enforcement activities of the Cecil County
20 Liquor Board.

21 **AND BE IT FURTHER RESOLVED** that this Resolution shall take effect on the date of its passage
22 by the County Council of Cecil County, Maryland.
