Title of Resolution: Supplemental Appropriation – Grant Funds – Community Services – Comprehensive Opioid, Stimulant, and Substance Use Program Grant.

Synopsis: A Resolution to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for the fiscal year ending June 30, 2024, in order to provide a total of \$982,806 to the Special Revenue Other Grants Fund, Fund 198, Department 536, to record an Office of Justice Programs grant awarded from the United States Department of Justice for staffing support, contracted trauma therapy services for children, family members and public safety personnel, equipment, and other targeted services to address opioid, stimulant and substance use in the community.

RESOLUTION NO. 66-2023
Supplemental Appropriation – Grant Funds – Community Services –
Comprehensive Opioid, Stimulant, and Substance Use Program Grant

1 **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2023, the
2 County Executive submitted a proposed budget to the County Council for Fiscal Year 2024; and

3 **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held
4 public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2024; and

5 **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 7, 2023, the
6 Budget for Cecil County was adopted for Fiscal Year 2024; and

7 **WHEREAS**, the County Executive is revising the Fiscal Year 2024 Special Revenue Other Grants
8 Fund, Fund 198, Department 536, revenue estimate for Cecil County to establish the following amount:
9 the addition of \$982,806 in grant revenue and expense to the Special Revenue Other Grants Fund to
10 provide for the grant from the Office of Justice Programs, United States Department of Justice; and

11 **WHEREAS**, such appropriation is necessary to provide \$982,806 in grant funding to provide
12 staffing support, contracted trauma therapy services for children, family members and public safety
13 personnel, equipment, and other targeted services to address opioid, stimulant and substance use in
14 the community.

15 **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**
16 **MARYLAND**, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for Fiscal
17 Year 2024 is hereby amended for the supplemental appropriation and by amending the Current Budget
18 to appropriate \$982,806 of additional revenue and expense in the Special Revenue Other Grants Fund,
19 Fund 198, Department 536, to record the grant awarded from the Office of Justice Programs, United
20 States Department of Justice.

21 **AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that
22 this Resolution shall take effect on the date of its passage by the County Council of Cecil County,
23 Maryland.
