**RESOLUTION NO. 05-2024**  
Reappointment – Weed Control Advisory Board

1           **WHEREAS**, Pursuant to Maryland Annotated Code, Agriculture Article, Section 9-2402(4), the Secretary  
2 of Agriculture may enter into agreements with any county subdivision of the State to effectuate a program of  
3 control and eradication of noxious weeds; and

4           **WHEREAS**, Pursuant to a Memorandum of Understanding between the Maryland Department of  
5 Agriculture and Cecil County, which was approved by the Cecil County Board of Commissioners on March 16,  
6 2010, the Cecil County Board of Commissioners agreed to appoint a Weed Advisory Committee to assist the  
7 Department of Agriculture in developing and implementing a Noxious Weed Control Program; and

8           **WHEREAS**, the Weed Advisory Committee of Cecil County works with the Roads Division of the  
9 Department of Public Works in providing oversight for the weed control program; and

10           **WHEREAS**, Article 4, Section 412(b) of the Charter of Cecil County provides, except as provided in  
11 Section 412(c) or prescribed by State law or other provisions, that the County Executive shall appoint all  
12 members of boards and commissions, subject to confirmation by the Council; and

13           **WHEREAS**, the County Executive has recommended the reappointment of Robert Weaver, Jim Calao,  
14 Charles Herzog, Kenneth Newcomb, Doris Behnke, and Ryan Fisher, Carroll Michael Scheeler, William Ewing,  
15 Jessica Edge Scott Heaps, John Fabian to the Cecil County Weed Control Board for a three-year term, which will  
16 expire on January 16, 2027.

17           **NOW THEREFORE, BE IT HEREBY RESOLVED THAT THE COUNTY COUNCIL OF CECIL COUNTY,**  
18 **MARYLAND**, confirms the recommendation by the County Executive of Robert Weaver, Jim Calao, Charles  
19 Herzog, Kenneth Newcomb, Doris Behnke, Ryan Fisher, Carroll Michael Scheeler, William Ewing, Jessica Edge,  
20 Scott Heaps, and John Fabian to the Cecil County Weed Control Board, which will expire on January 16, 2027.

21           **AND, BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that this  
22 Resolution shall take effect on the date of its passage.
