1	WHEREAS, in accordance with Section 505 of the Cecil County Charter, on April 1, 2023, the	
2	County Executive submitted a proposed budget to the County Council for Fiscal Year 2024; and	
3	WHEREAS, in accordance with Section 506 of the Cecil County Charter, the County Council held public	
4	hearings on the proposed budget submitted by the County Executive for Fiscal Year 2024; and	
5	WHEREAS, in accordance with Section 507(b) of the Cecil County Charter, on June 6, 2023, the Budget	
6	for Cecil County was adopted for Fiscal Year 2024; and	
7	WHEREAS, the County Executive is revising the Fiscal Year 2024 expenditure for Cecil County to	
8	increase use of the Assigned Fund Balance to allow the following appropriations within the General Fund:	
9	a) Cardiac monitor \$38,864 of which \$10,000 will be reimbursed by grant funds after the	
10	expenditure;	
11	b) Two (2) portable radios \$19,490 which will be reimbursed fully by grant funds after	
12	expenditure;	
13	c) Five (5) Automatic External Defibrillators \$11,112, and	
14	d) Miscellaneous radio and radio system parts \$15,400	
15	WHEREAS, such appropriation is necessary to provide \$84,866 of the County Executive's	
16	FY2024 assigned fund balance for the General Fund for expenditures.

18	the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for Fiscal Year 2024 is hereby

20	\$84,866 of additional expenditures from the General Fund to the Department of Emergency Service's	
21	budget.
