1	WHEREAS, in accordance with Section 505 of the Cecil County Charter, on April 1, 2023, the
2	County Executive submitted a proposed budget to the County Council for Fiscal Year 2024; and
3	WHEREAS, in accordance with Section 506 of the Cecil County Charter, the County Council held
4	public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2024; and
5	WHEREAS, in accordance with Section 507(b) of the Cecil County Charter, on June 6, 2023, the
6	Budget for Cecil County was adopted for Fiscal Year 2024; and
7	WHEREAS, the County Executive is revising the Fiscal Year 2024 Special Revenue Other Grants
8	Fund – Office of Economic Development revenue estimate for Cecil County to establish the following
9	amount: the addition of \$42,000 in grant revenue and expense to the Special Revenue Other Grants
10	Fund – Office of Economic Development budget to provide for the cost share grant program from the
11	MARBIDCO awarded to Cecil County; and
12	WHEREAS, such appropriation is necessary to provide \$42,000 in program funding as a source
13	of matching funds for the Agricultural Microgrant Program. The goal of the program is to foster growth
14	in Maryland's existing and emerging agricultural and resource-based businesses by working with local
15	and regional economic development offices. These matching grants are provided to local and regional
16	economic development entities to co-fund significant agricultural projects.
17	NOW THEREFORE, BE IT HEREBY RESOLVED that the Annual Budget and Appropriation
18	Ordinance for Cecil County, Maryland for Fiscal Year 2024 is hereby amended for the supplemental
19	appropriation and by amending the Current Budget to appropriate \$42,000 in additional expenditures
20	in the Special Revenue Other Grants Fund for the Office of Economic Development, in order to record
21	the grant awarded from MARBIDCO, for the purpose of matching the Agricultural Microgrant program
22	in Cecil County.

24	by the County Council of Cecil County, Maryland.
