**Synopsis:** A Resolution to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland, for the fiscal year ending June 30, 2024, in order to provide a total of \$112,320 to the Special Revenue Other Grants Fund, Office of Economic Development, to record the grant awarded from the Maryland Department of Commerce, Economic Development Administration (EDA) for the purpose to allow the County to develop signage, literature, web pages, a video, and to market our sites and stories to visitors and locals.

Supplemental Appropriations – Grant Funds –

1           **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2023, the County  
2 Executive submitted a proposed budget to the County Council for Fiscal Year 2024; and

3           **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held public  
4 hearings on the proposed budget submitted by the County Executive for Fiscal Year 2024; and

5           **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 6, 2023, the Budget for  
6 Cecil County was adopted for Fiscal Year 2024; and

7           **WHEREAS**, the County Executive is revising the Fiscal Year 2024 Special Revenue Other Grants Fund – Office  
8 of Economic Development revenue estimate for Cecil County to establish the following amount: the addition of  
9 \$112,320 in grant revenue and expense to the Special Revenue Other Grants Fund – Office of Economic  
10 Development budget to provide for the grant from the Maryland Department of Commerce, Economic  
11 Development Administration (EDA) awarded to Cecil County; and

12           **WHEREAS**, such an appropriation is necessary to provide \$112,320 in grant funding for the purpose of  
13 allowing the County to develop signage, literature, web pages, a video, and to market our sites and stories to  
14 visitors and locals; and

15           **WHEREAS**, our goal is to interpret and promote our designated Network to Freedom sites to honor our  
16 unique heritage and stories of courage, while generating visitor spending and support for the local economy.

17           **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that  
18 the Annual Budget and Appropriation Ordinance for Cecil County, Maryland, for Fiscal Year 2024 is amended for the  
19 supplemental appropriation, and by amending the Current Budget, to appropriate \$112,320 in additional  
20 expenditures in the Special Revenue Other Grants Fund – Office of Economic Development, to record the grant  
21 awarded by the Maryland Department of Commerce, EDA, for the purpose to allow the County to develop signage,  
22 literature, web pages, a video, and to market our sites and stories to visitors and locals.

23           **AND BE IT FURTHER RESOLVED** that this Resolution shall take effect on the date of its passage by the  
24 County Council of Cecil County, Maryland.
