Appointment—Emergency Medical Services Advisory Board – Nathan Stewart, Melissa Kinsler, and Robert Muller

WHEREAS, pursuant to Chapter 34, Section 34-4 of the Code of Cecil County, the Department of Emergency Services shall be responsible for coordinating emergency medical services within Cecil County in accordance with the Code of Maryland Regulations (COMAR) Title 30; and WHEREAS, pursuant to Chapter 16, Section 30-30, the Emergency Medical Services Advisory Board provides oversight of Cecil County's career EMS Supplement Services, which are supported by the Department of Emergency Services; and WHEREAS, this Board shall function as an advisory role and render recommendations to the County Administration through the Director of Emergency Services on operational issues, which will sustain the career/volunteer relationship that renders the best delivery of Emergency Medical Services to meet the needs of Cecil County; and WHEREAS, the Board consists of fifteen (15) voting members, which include nine (9) members representing the nine-volunteer fire/EMS companies; five (5) members representing each of the five councilmanic districts; and one (1) member representing the IAFF Local; and three (3) non-voting Ex-Officio members that include the Director of the Department of Emergency Services; Local Physician EMS Medical Director; and one (1) representative of the Cecil County Firemen's Association; and WHEREAS, Article 4, Section 412 (b) of the Charter of Cecil County provides, except as provided in Section 412(c) or prescribed by State Law or other provisions, that the County Executive shall appoint all members of boards and commissions, subject to confirmation by the Council; and WHEREAS, the County Executive is recommending the following members to the Emergency Medical Services Advisory Board for a three-year term, which is to expire on June 1, 2024: Nathan Stewart, filling the vacancy of Stephen Cummins III, representing IAFF Local 4645, Melissa Kinsler, filling the vacancy of Rodney Heinze, representing Councilmanic District 2, Robert Muller, filling the vacancy of Richard Collins, representing Cecil County Firemen's Association (Ex-Officio).
