Appointment—Emergency Medical Services Advisory Board –

1 **WHEREAS**, pursuant to Chapter 34, Section 34-4 of the Code of Cecil County, the Department of
2 Emergency Services shall be responsible for coordinating emergency medical services within Cecil County
3 in accordance with the Code of Maryland Regulations (COMAR) Title 30; and

4 **WHEREAS**, pursuant to Chapter 16, Section 30-30, the Emergency Medical Services Advisory Board
5 provides oversight of Cecil County’s career EMS Supplement Services, which are supported by the
6 Department of Emergency Services; and

7 **WHEREAS**, this Board shall function as an advisory role and render recommendations to the
8 County Administration through the Director of Emergency Services on operational issues, which will
9 sustain the career/volunteer relationship that renders the best delivery of Emergency Medical Services to
10 meet the needs of Cecil County; and

11 **WHEREAS**, the Board consists of fifteen (15) voting members, which include nine (9) members
12 representing the nine-volunteer fire/EMS companies; five (5) members representing each of the five
13 councilmanic districts; and one (1) member representing the IAFF Local; and three (3) non-voting
14 Ex-Officio members that include the Director of the Department of Emergency Services; Local Physician
15 EMS Medical Director; and one (1) representative of the Cecil County Firemen’s Association; and

16 **WHEREAS**, Article 4, Section 412 (b) of the Charter of Cecil County provides, except as provided in
17 Section 412(c) or prescribed by State Law or other provisions, that the County Executive shall appoint all
18 members of boards and commissions, subject to confirmation by the Council; and

19 **WHEREAS**, the County Executive is recommending the following members to the Emergency
20 Medical Services Advisory Board for a three-year term, which is to expire on June 1, 2024:

21 Nathan Stewart, filling the vacancy of Stephen Cummins III, representing IAFF Local 4645,
22 Melissa Kinsler, filling the vacancy of Rodney Heinze, representing Councilmanic District 2,
23 Robert Muller, filling the vacancy of Richard Collins, representing Cecil County Firemen’s
24 Association (Ex-Officio).

25 **NOW, THEREFORE, BE IT HEREBY RESOLVED THAT THE COUNTY COUNCIL OF CECIL COUNTY,**
26 **MARYLAND**, confirms the recommendation by the County Executive of Nathan Stewart, filling the vacancy
27 of Stephen Cummins III, representing IAFF Local 4645, Melissa Kinsler, filling the vacancy of Rodney
28 Heinze, representing the Councilmanic District 2, and Robert Muller, filling the vacancy of Richard Collins,
