Call to Order & Welcome – Mike Ratchford

- Meeting called to order at 8:01 am
- Meeting minutes approved for October 2023 and December 2023

Chairman's Report – Mike Ratchford

MD legislature back in session in a week or so – report from MD Chamber this morning

Director's Report - Bill Sorenson

- Jan. 11 Cecil Night in Annapolis; Jan. 22 State of the Economy Breakfast Hope to see everyone there
- New Rt. 40 Revitalization Grant now available for businesses on Rt. 40 to help beautify facades

A 2024 Legislative Outlook was presented by Hannah Allen, Government Affairs Associate, MD Chamber of Commerce

- Top issues Chamber will be focused on:
 - Taxes/Business Taxes
 - MD Budget deficit to get to \$2B by FY28/29; Blueprint for Education taking up a lot of money
 - State spending more than revenue received need to balance
 - Corporate & Business Taxes
 - Corporations & businesses looked at first for revenue
 - Combined Reporting best solution for corporations doing work in other states but not paying taxes
 - Debate over whether this would be helpful; Adopting this reporting not bringing in increased revenue to other states
 - Defer businesses from locating in states with legislation

- Increased focus on revenue raisers
- Corporate Income Tax Rate seeing neighboring states act more aggressive to lower rate and attract businesses; i.e., Pennsylvania had highest rate, will lower to 4.9% over next 8-10 years; NJ letting temporary surcharge expire; Virginia is 6%
- Raising Maryland's corporate income tax rate will not attract businesses to the State
- Other revenue options:
 - iGaming = \$900M/year revenue potential
 - Millionaire Tax = \$775,000 or more/year
- Transportation bill passed on MD Commission on Transportation Revenue and Infrastructure needs
 - Make recommendations to trust fund and revenues for trans projects, project prioritization, processes
 - More electrical vehicles being used instead of gas losing revenue
 - Jan 2025 final Interim Report due; interim report now available
 - Options; new registration for electric vehicles
 - MDTA increase toll rates (mostly out-of-state passes)
 - Prioritizing Projects deciding what to include in consolidated transportation plan
 - MD has worst road maintenance, long commute times, highway congestion
 - Governor making large cut (approx. \$3M) to transportation budget
 - Once draft budget out from Governor, Gen. Assy. can make changes
- Data Privacy
 - Private industry needs to prepare how State will use & regulate data
 - Want to ensure in a patchwork policy; Every State has own law currently
 - Opens unnecessary law suits for companies who collect data; disincentivizes businesses
- AI -- Nothing really regulates; 8-10 states have passed regulations; want to mirror policy for data privacy
- Military Retirement Leave recruiting and retaining miliary retirees
 - People leave military and move out of state; takes knowledge/experience out of MD
 - Eliminate State's income tax for military retiree income
 - Gov. Moore has big focus on supporting vets; keep workforce in MD including spouses and adult children
 - Governor designated 2024 year of military families; legislation to be introduced
 - Preferential Hiring Process (to include spouses); Military Status (as protected class)

Childcare

- Affordability and availability are State priority
- MD has one of lowest unemployment rates
- Labor participation down people not returning to workforce
- Big issue is childcare
- Need to incentivize childcare options i.e., stipends in employment benefits
- Affects attracting workers
- Will be year of the budget
- Topics for Focus:
 - Unemployment Insurance Last session bill introduced to overhaul program –did not pass
 - Ensure healthy and sustainable balance of UI fund without increased costs to employers will see similar bill this year

- Energy & Environment
 - MDE released final report outlining proposals and initiatives (i.e., tax on greenhouse gases)
 - MDE building energy performance regulations out for public comment till Jan 18 goal to
 - place energy performance standards on covered buildings 35,000+ sq. ft.
 - Goal to achieve Net Zero Greenhouse Gases by 2040
- Paid Family Leave anticipate seeing changes to that program

A Blueprint Update for Cecil County Public Schools was presented by Dr. Jeffrey Lawson, Superintendent, CCPS

- Presentation (attached) outlines the Five Pillars of Implementing the Blueprint for Maryland's future
 - Cites current status as well as challenges presented for Cecil County Public Schools
- Closing Thoughts:
 - Indicator for success for 3-4 year old is education of mother
 - Cecil County lowest funded county in state of MD
 - Expected funding shortfall \$15M-\$20M for FY25
 - Current Operating Budget \$260M/year
 - Looking at 8-10% in reductions; Expect cuts in programs, administrative, teachers
