1           **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2015, the County  
2 Executive submitted a proposed budget to the County Council for Fiscal Year 2016; and

3           **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held  
4 public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2016; and,

5           **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 2, 2015, the  
6 County Council adopted the budget for Fiscal Year 2016; and

7           **WHEREAS**, the County Executive is revising the Fiscal Year 2016 revenue estimate for Cecil County  
8 to increase use of Fund Balance by \$5,585 to allow the following appropriation within the General Fund:

- 9           a) The addition of \$5,585 in expenditures to the Maryland School for the Blind’s budget to  
10 accommodate the enrollment of additional students for the 2015 - 2016 school year.

11           **WHEREAS**, such appropriation is necessary to provide \$5,585 of fund balance for the General Fund  
12 for expenditures within the Maryland School for the Blind budget.

13           **NOW THEREFORE, BE IT HEREBY RESOLVED** that the Annual Budget and Appropriation Ordinance for  
14 Cecil County, Maryland for Fiscal Year 2016 is hereby amended for the supplemental appropriation and by  
15 amending the Current Budget to appropriate \$5,585 of additional expenditures in the General Fund.

16           **AND BE IT FURTHER RESOLVED** that this Resolution shall take effect on the date of its passage by the  
17 County Council of Cecil County, Maryland.
