**Title of Resolution:** Supplemental Appropriation - Sheriff's Office - Sex Offenders Registry

**Synopsis:** A Resolution to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for the fiscal year ending June 30, 2016 in order to provide a total of \$5,250 in additions to the General Fund Grants Budget awarded to the Sheriff's Office – Law Enforcement from the Maryland Department of Public Safety and Correctional Services to update IT equipment in order to maintain substantial compliance with the federal Sex Offender Registration, Notification and Apprehension Act.

Supplemental Appropriation - Sheriff's Office - Sex Offender Registry

1       **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2015, the County  
2 Executive submitted a proposed budget to the County Council for Fiscal Year 2016; and

3       **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held  
4 public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2016; and

5       **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 2, 2015, the  
6 County Council adopted the budget for Fiscal Year 2016; and

7       **WHEREAS**, the County Executive is revising the Fiscal Year 2016 General Fund Budget Cecil County  
8 to establish the following amounts within the General Fund as follows:

- 9           a) The addition of \$5,250 in grant revenue and expense within the Sheriff’s Office from the
- 10                 Maryland Department of Public Safety and Correctional Services – Information Technology and
- 11                 Communications Division to provide funding to update IT equipment in order to maintain
- 12                 substantial compliance with the federal Sex Offender Registration, Notification and
- 13                 Apprehension Act.

14       **WHEREAS**, such appropriation is necessary to provide \$5,250 of grant funding for the General Fund  
15 for grant related expenses within the Sheriff’s Office.

16       **NOW THEREFORE, BE IT HEREBY RESOLVED** that the Annual Budget and Appropriation Ordinance for  
17 Cecil County, Maryland for Fiscal Year 2016 is hereby amended for the supplemental appropriation and by  
18 amending the Current Budget to appropriate additional revenue and expenditures in the General Fund  
19 Grants Budget in the amount of \$5,250 within the Sheriff’s Office – Law Enforcement budget.

20       **AND BE IT FURTHER RESOLVED** that this Resolution shall take effect on the date of its passage by the  
21 County Council of Cecil County, Maryland.
