1 **WHEREAS**, pursuant to Education Article of the Annotated Code of Maryland, Section 23-403, the
2 boards of library trustees consists of seven members appointed by the county governing body from
3 nominees submitted by the board of library trustees; and

4 **WHEREAS**, the members of board of library trustees are chosen on the basis of character, ability
5 and demonstrated interest in library matters; and

6 **WHEREAS**, members of the board shall be representatives of the area that the library serves and
7 residents of the county;

8 **WHEREAS**, a member of a board serves for five years and until a successor is appointed and
9 qualified, and a member may be reappointed, but may not serve more than two consecutive terms; and

10 **WHEREAS**, each board of library trustees shall establish and operate the library to provide free
11 services to resident of the county, establish and operate libraries at any locations in the county,
12 determine the policy of the library and adopt reasonable rules, regulations, and bylaws for use of the
13 library and the conduct of its business; and

14 **WHEREAS**, the Cecil County Board of Library Trustees plans and sets policy for and operates the
15 Cecil County Public Library; and

16 **WHEREAS**, Article 4, Section 412 (b) of the Charter of Cecil County provides that the County
17 Executive shall appoint all members of boards and commissions, subject to confirmation by the Council;
18 and

19 **WHEREAS**, the County Executive has reappointed Kennard Wiggins Jr. to the Board of Library
20 Trustees, for a five year term to expire on January 5, 2021.

21 **NOW, THEREFORE, BE IT HEREBY RESOLVED** that the County Council of Cecil County confirms the
22 reappointment, by the County Executive, of Kennard Wiggins Jr. to the Board of Library Trustees, for a five
23 year term to expire on January 5, 2021.
