Synopsis: A Resolution to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for the fiscal year ending June 30, 2024, in order to provide a total of \$241,955 to the Community Services Grants Fund. Specifically, \$127,955 – Cecil Transit Division, Fund 109, Department 522, to record a Statewide Transit Innovation Grant awarded by the Maryland Transit Administration; \$105,000 - Community Partnerships Division, Fund 109, Department 536, to record a grant awarded by the Maryland Community Health Resource Commission; and \$9,000 – Community Partnerships Division, Fund 109, Department 163, to record a grant awarded by the Maryland State Department of Juvenile Services. Funding awarded through these grants will be used to support a routing software system in Cecil Transit, employ a contractual family navigator to work with the County's Local Care Team and offset expenses associated with the Department's Neighborhood Youth Panel Program, respectively.

WHEREAS, in accordance with Section 505 of the Cecil County Charter, on April 1, 2023, the 1 2 County Executive submitted a proposed budget to the County Council for Fiscal Year 2024; and 3 WHEREAS, in accordance with Section 506 of the Cecil County Charter, the County Council held 4 public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2024; and 5 WHEREAS, in accordance with Section 507(b) of the Cecil County Charter, on June 6, 2023, the Budget for Cecil County was adopted for Fiscal Year 2024; and 6 7 WHEREAS, the County Executive is revising the Fiscal Year 2024 Community Services Grants 8 Fund – Department of Community Services – Cecil Transit Division, Fund 109, Department 522, revenue 9 estimate for Cecil County to establish the following amount: the addition of \$127,955 in grant revenue 10 and expense to the Community Services Grants Fund – Community Partnerships Division, Fund 109, 11 Department 536, revenue estimate for Cecil County to establish the following amount: the addition of \$105,000 in grant revenue and expense to the Community Services Grants Fund and; Community 12 Partnerships Division, Fund 109, Department 163, revenue estimate for Cecil County to establish the 13 14 following amount: the addition of \$9,000 in grant revenue and expense to the Community Services Grants Fund, to provide for grants from the Maryland Transit Administration, the Maryland Community 15 16 Health Resource Commission and the Maryland State Department of Juvenile Services, respectively; 17 and 18 WHEREAS, such appropriation is necessary to provide a total of \$241,955 in grant funding to 19 support a routing software system in Cecil Transit, employ a contractual family navigator to work with 20 the County's Local Care Team and offset expenses associated with the Department's Neighborhood Youth Panel Program, respectively. 21 NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, 22 23 MARYLAND, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for Fiscal Year 2024 is hereby amended for the supplemental appropriation and by amending the Current Budget 24 25 to appropriate \$241,955 of additional expenditures in the Community Services Grants Fund – 26 Department of Community Services, Fund 109, Departments 522, 536 and 163, to record grants 27 awarded from the Maryland Transit Administration, the Maryland Community Health Resource

Commission and the Maryland State Department of Juvenile Services, respectively.
