| 1 | WHEREAS, in accordance with Section 505 of the Cecil County Charter, on April 1, 2015, the County |

| 3 | WHEREAS, in accordance with Section 506 of the Cecil County Charter, the County Council held |
| 4 | public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2016; and |
| 5 | WHEREAS, in accordance with Section 507(b) of the Cecil County Charter, on June 2, 2015, the |
| 6 | County Council adopted the budget for Fiscal Year 2016; and |
| 7 | WHEREAS, the County Executive is revising the Fiscal Year 2016 revenue estimate for Cecil County |
| 8 | to increase use of fund balance by \$24,000 to allow the following appropriation within the General Fund |
| 9 | Animal Control Budget as follows: |
| 10 | a) The addition of \$24,000 in expenditure authority within the Animal Control Budget to allow for |
| 11 | the first addendum to the Cecil County Animal Care and Control Contract effective on |
| 12 | January 1, 2016 between Cecil County, Maryland and AB4L (A Buddy for Life). |
| 13 | WHEREAS, after review of the Request for Proposal's (RFP's) received by the County from animal |
| 14 | care and control vendors, the County Executive believes it is in the best interest of Cecil County to extend |
| 15 | the current animal control contract with the vendor currently providing the service for Cecil County for an |
| 16 | additional six months; and |
| 17 | WHEREAS, the County has extended the current contract and has agreed to pay the current vendor |
| 18 | \$271,020 for the remainder of fiscal year 2016 in order to fulfill the obligations of the contract and provide |
| 19 | animal care and control as defined in Chapter 142 of the Cecil County Code; and |
| 20 | WHEREAS, the County will also allow the two County purchased vehicles that are deemed essential |
| 21 | to providing animal control services, pursuant to the Contract and First Addendum, to be serviced regularly |
| 22 | by the County's fleet service vendor. The County will provide the regular scheduled maintenance for the |
| 23 | animal control vehicles for the remainder of fiscal year 2016; and |
| 24 | WHEREAS, even though the monthly costs in the second half of FY2016 have been reduced by |
| 25 | \$6,000, the current budget for Animal Control within the General Fund is insufficient to support the |
| 26 | projected costs of animal care and control through the end of the year; and |
| 27 | WHEREAS, such appropriation is necessary to provide \$24,000 of fund balance for the General |

Fund for expenditures within the Animal Control Budget.
