- Meeting minutes approved for January 2024

Chairman's Report - Mike Ratchford

 Chamber hosted State of the Economy breakfast – great turnout; good to hear from County Executive re improved bond rating

Director's Report – Sandra Edwards for Bill Sorenson

- March 2 4th Annual Rooted in Our Community event @ Cecil College, TC208, 9:00am-1:30pm
 - Focus will be on climate change
 - Serving continental breakfast, lunch, and treats; will be a drone demonstration at end of session
 - Students from Cecil County School of Technology will be conducting a panel
- Rt. 40 Revitalization Grant currently have 4 applications; please spread word about grant
- Feb. 15 Micro Ag Grant application deadline; 11 applications thus far but expect more; grants up to \$10,000, total of \$84,000 grant funding this year
- Apr. 28 May 4 National Small Business Week
 - Ideas/suggestions on how to celebrate are welcome
 - Will have business visits, possibly host workshop
- March 20 Hart Print Ribbon Cutting; small new manufacturer in Free State Business Park, Elkton
 - 20 new jobs anticipated to start up to 50
 - Custom printing on labels for aluminum cans
- Richard Starr has left OED and relocated to Massachusetts
- Winter Lights/Cecil Nights few more weeks left; check website for events
- County Council accepted EDA grant, the Network to Freedom
 - Tourism to manage grant on 3 sites designated; have until end of 2025 to complete project
- Tourism working on updating Visitor Guide

An update on utilities (gas) was presented by Randy Baynes, Sr. Economic Development Specialist, BGE

- Primary contact for Cecil and all Central Maryland counties
- Limited in Cecil County
- BGE is gas utility, not electric utility in Cecil
- Increased activity with Great Wolf Lodge, Bainbridge, across Rt. 40 corridor
- Have incentive called SEED (Smart Energy Economic Development)
 - Have ability to influence cost of projects located in enterprise zone; looking to increase to opportunity zones
- Work with developers, county economic development offices, State of MD Dept. of Commerce
- Enlarging gas footprint dependent on future projects
- Cooperative understanding with other utility companies

An update on utilities (natural gas) was presented by Vince Fiorelli, Chesapeake Utilities

- History: Began as Dover Gas & Light in 1859; incorporated in State of Delaware 1947; Eastern Shore Natural Gas incorporated in Delaware 1955 (now oversee transportation of natural gas from neighboring states and Delaware); 1959 Eastern Shore Natural Gas extended pipeline from Parkesburg, PA to Salisbury MD; Sharp Energy, a subsidiary, formed in 1981
 - In Delmarva Peninsula have natural gas and propane
 - Acquired Central Florida Gas Company in 1985; common stock began trading on Nasdaq same year
 - 1993 Chesapeake Utilities Corp began trading on New York Stock Exchange
 - Purchased Florida Public Utilities in 2009 distribute natural gas, propane, and electricity throughout State of Florida
 - Large footprint in Florida and up and down East Coast
 - 2013 First natural gas customer in Cecil County; currently serving about 7,000 customers in Cecil
 - 2013 Purchased operating assets from Eastern Shore Gas to serve Worcester Co., MD
 - 2016 Opened 8 Flags Energy combined heat & power plant on Amelia Island, FL
 - 2019 Completed Eastern Shore natural gas expansion largest single transmission expansion in company's history
- In Cecil County:
 - Rt. 40 pipeline extends 9 mi. from Nottingham Rd, Elkton by YMCA and Thiokol to Belvidere Rd, Perryville
 - Large projects underway: Belvidere Road Main Extension, approx. 9500 ft. of main extension, to coincide with Belvidere Rd. I-95 Interchange
 - Principio Parkway East, 4500 ft., to fee 2 new distribution facilities; hoping to get Restoration Hardware as customer
 - Rt. 40, North East Chipotle & Starbucks, North East Library
 - Elkton Thiokol new construction; main extension added for Southfields Phase I and future projects, Sheetz
 - Town of Elkton Replaced all old Allied pipeline, 22,000 ft. or 4.3 mi. replaced, 289 services replaced, completed 10/2023, just under \$2.5M
 - Southern Cecil 15,000 ft natural gas main extension from Warsaw Manor Rd (Sun Med Growers, mushroom farm) to west side of Cecilton Elementary (hoping to convert school)

A Broadband Update was presented by David Black, GIS Manager for Cecil County

- History of Cecil County's Broadband (BB) Grants to date:
 - Grant Award Amount: \$16,932,823

County Matching Funds: \$2,184,636
ISP Matching Funds: \$5,823,319
Number of addresses: 2,577
Cost per connection: \$9,678
County % of funding: 8.76%

Total # of addresses in Cecil County: 47,902
Addresses lacking broadband prior to 2019: 2,688
% of addresses lacking broadband: 5.31%
Addresses completely connect since then: 1,187
Addresses underway (funding, construction, etc.): 1,390
% of addresses lacking broadband: 0.23%

- Final 100-150 addresses (no funding secured) to be most difficult due to remote locations, unusual circumstances, etc.
- Some wireless solutions used 4-5 yrs. ago no longer up to task
- FCC definition of BB (25 Mbps down/3 Mbps up) no longer matches State and BEAD definitions (100 Mbps symmetrical)
- Some address may cycle back to "unserved" given changing criteria
- Maps (handout attached) designate locations in Cecil County of:
 - Verizon Remote Central Offices
 - Verizon "Bainbridge" Fiber Feeder Route (35.3 mi.)
 - Verizon "North East" Fiber Feeder Route (17.57 mi.)
 - Verizon "Elkton" Fiber Feeder Route (28.56 mi.)
 - Verizon "Chesapeake City" Fiber Feeder Route (12.33 mi.)
