WHEREAS, Section 505 of the Charter of Cecil County requires the Executive to prepare a Proposed Capital Improvement Program as part of the Budget Message to County Council for the ensuing fiscal year not later than April 1 of each year; and WHEREAS, the County Executive will submit on May 20, 2024 the proposed Capital Improvement Program for Fiscal Years 2025-2029 to the Cecil County Planning Commission for review and consideration; and WHEREAS, any projects contained in the Capital Improvement Program for Fiscal Years 2025-2029 that require Planning Commission approval will be considered and recommended to remain part of the Capital Improvement Program for Fiscal Years 2025-2029; and WHEREAS, any projects contained in the Capital Improvement Program for Fiscal Years 2025-2029 that the Planning Commission does not recommend for approval will be amended and be removed from Capital Improvement Program for Fiscal Years 2025-2029; and WHEREAS, on April 1, 2024, the County Executive submitted the proposed Capital Improvement Program for Fiscal Years 2025–2029 to the County Council indicating the intention of the County to receive and expend funds for capital projects, and providing for each capital project, the project description, estimated costs and probable sources of funding; and WHEREAS, the Cecil County Council has met all the requirements to consider the Capital Improvement Program for Fiscal Years 2025–2029. NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND that the Capital Improvement Program for the fiscal years ending June 30, 2025, June 30, 2026, June 30, 2027, June 30, 2028, and June 30, 2029, attached as Appendix 1, is approved and adopted. **AND BE IT FURTHER RESOLVED** that this Bill shall take effect on July 1, 2024.
