 - Cecil College received \$13K grant from Delmarva to support planning and program launch
 - Launch 1st cohort in Q2 2024
 - To support future workforce and keep people in Cecil County
 - Exelon feels strongly about workforce development being part of future of communities

Community Impact Capital Fund

- Strengthen our communities and help businesses grow
 - \$36 million in funding commitment
 - Providing affordable capital to businesses challenged in accessing and securing funding
 - Increasing business capacity and subsequent employment opportunities for diverse local communities
 - Leverage fund through partnerships
 - Loans between \$100,000-\$600,000; equity investment up to \$2 million
 - Nearly \$4 million in investments distributed

- Funding \$3M asphalt overlay to repair roads in the spring

- State of MD recommending collective \$22M decrease in funding for community colleges; would result in \$1M decrease in funding for Cecil College
