**RESOLUTION NO. 21-2024**

**Title of Resolution:** Charter Amendment – Compensation – County Council

**Synopsis:** A Resolution amending Article 2, County Council, Section 207, Compensation of the Cecil County Charter to provide that the County Council shall receive as compensation \$35,000 per annum. To require submission of this amendment to the legally qualified voters of Cecil County for their adoption or rejection, in accordance with Section 602 of the Charter of Cecil County.

1           **WHEREAS**, pursuant to Article 6, Section 602 of the Cecil County Charter, the Charter  
2 may be amended by the procedures provided in Article XI-A of the Maryland Constitution; and

3           **WHEREAS**, pursuant to Article XI-A, §5 of the Maryland Constitution, amendments to  
4 any charter adopted by any County of this State under the provisions of this Article may be  
5 proposed by a resolution of the Council of the County, or by a petition signed by not less than  
6 20% of the registered voters of the City or County, provided, however, that in any case 10,000  
7 signatures shall be sufficient to complete a petition; and

8           **WHEREAS**, pursuant to Md. Code Ann., §7-103(a)(iii) and §7-103(c)(3)(i) of the Election  
9 Law Article, the Attorney, designated to represent the county legislative body, shall prepare  
10 and certify, and submit to the State Board of Election, not later than August 1, 2024, the  
11 following information as required under §7-103(b) of the Election Law Article for each question  
12 to be voted on in the County: (1) a question number or letter as by the Election Board; (2) a  
13 brief designation of the type or source of the question; (3) a brief descriptive title in boldface  
14 type; (4) a condensed statement of the purpose of the question; and (5) the voting choices that  
15 the voter has; and

16           **WHEREAS**, pursuant to Article 6, Section 602 of the Cecil County Charter and  
17 Article XI-A, §5 of the Maryland Constitution, the amendments shall be published by the  
18 President of the County Council once a week for five successive weeks prior to the election in at  
19 least one newspaper published in said County; and

20           **WHEREAS**, pursuant to Article 6, Section 602 of the Cecil County Charter and  
21 Article XI-A, §5 of the Maryland Constitution, an amendment so proposed shall be submitted to  
22 the voters of the County at the next general or congressional election occurring after the  
23 passage of the resolution; and

24           **WHEREAS**, in accordance with Article 6, Section 602 of the Cecil County Charter and  
25 Article XI-A, §5 of the Maryland Constitution, if at the election the majority of the votes cast for  
26 the amendment shall be in favor thereof, the amendment shall be adopted and become a part  
27 of the charter of the County from and after the thirtieth day after said election; and

28           **WHEREAS**, Article 2, County Council, Section 207, Compensation, of the Cecil  
29 County Charter currently provides that:

30 “Each Council member shall receive as compensation and allowances for the performance  
31 of public duties under this Charter the sum of not less than \$25,000 per annum. A Council  
32 member shall not accrue annual leave or be entitled to any payment in lieu thereof. The  
33 compensation and allowances shall be in full compensation for all services performed by  
34 members of the Council as required by this Charter, but shall not preclude reasonable and  
35 necessary expenses as may be provided in the budget. The County Council shall establish  
36 by ordinance a Compensation Review Commission every four years to review the Council's  
37 compensation and allowances in accordance with the provisions of Article 25A, Subsection  
38 5(AA), of the Annotated Code of Maryland”; and

39 **WHEREAS**, in accordance with Article 6, Section 602 of the Cecil County Charter and  
40 Article XI-A, §5 of the Maryland Constitution, this Resolution proposes the following  
41 amendment to Article 2, County Council, Section 207, Compensation, of the Cecil County  
42 Charter:

43 “Each Council member shall receive as compensation and allowances for the performance  
44 of public duties under this Charter the sum of not less than \$25,000 per annum **AND**  
45 **STARTING ON DECEMBER 04, 2028, \$35,000 PER A 12 MONTH PERIOD**. A Council member  
46 shall not accrue annual leave or be entitled to any payment in lieu thereof. The  
47 compensation and allowances shall be in full compensation for all services performed by  
48 members of the Council as required by this Charter, but shall not preclude reasonable and  
49 necessary expenses as may be provided in the budget. The County Council shall establish  
50 by ordinance a Compensation Review Commission every four years to review the Council's  
51 compensation and allowances in accordance with the provisions of Article 25A, Subsection  
52 5(AA), of the Annotated Code of Maryland.”

53 **NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL**  
54 **COUNTY, MARYLAND**, that the following amendment to Article 2, County Council, Section 207,  
55 Compensation, of the Cecil County Charter, shall be submitted to the voters of the County at  
56 the next general or congressional election in accordance with Article 6, Section 602 of the Cecil  
57 County Charter and Article XI-A, §5 of the Maryland Constitution:

58 “Each Council member shall receive as compensation and allowances for the performance

59 of public duties under this Charter the sum of not less than \$25,000 per annum **AND**  
60 **STARTING ON DECEMBER 04, 2028, \$35,000 PER A 12 MONTH PERIOD.** A Council member  
61 shall not accrue annual leave or be entitled to any payment in lieu thereof. The  
62 compensation and allowances shall be in full compensation for all services performed by  
63 members of the Council as required by this Charter, but shall not preclude reasonable and  
64 necessary expenses as may be provided in the budget. The County Council shall establish  
65 by ordinance a Compensation Review Commission every four years to review the Council's  
66 compensation and allowances in accordance with the provisions of Article 25A, Subsection  
67 5(AA), of the Annotated Code of Maryland.”

68 **AND BE IT HEREBY FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL**  
69 **COUNTY, MARYLAND,** that, pursuant to Md. Code Ann., §7-103(a)(iii) and §7-103(c)(3)(i)  
70 of the Election Law Article, the Attorney, designated to represent the county legislative  
71 body, shall prepare, certify, and submit to the State Board of Election, not later than  
72 August 1, 2024, the following information as required under §7-103(b) of the Election Law  
73 Article: (1) a question number or letter as by the Election Board; (2) a brief designation of  
74 the type or source of the question; (3) a brief descriptive title in boldface type; (4) a  
75 condensed statement of the purpose of the question; and (5) the voting choices that the  
76 voter has.

77 **AND BE IT HEREBY FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**  
78 **MARYLAND,** that pursuant to Article 6, Section 602 of the Cecil County Charter and Article XI-A,  
79 §5 of the Maryland Constitution, the amendments shall be published by the President of the  
80 County Council once a week for five successive weeks prior to the election in at least one  
81 newspaper published in said County.

82 **AND BE IT HEREBY FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**  
83 **MARYLAND,** that pursuant to Article 6, Section 602 of the Cecil County Charter and Article XI-A,  
84 §5 of the Maryland Constitution, the aforementioned proposed amendment shall be submitted  
85 to the voters of the County at the next general or congressional election occurring after the  
86 passage of this Resolution.

87           **AND BE IT HEREBY FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**  
88   **MARYLAND**, that in accordance with Article 6, Section 602 of the Cecil County Charter and  
89   Article XI-A, §5 of the Maryland Constitution, if at the election the majority of the votes cast for  
90   the aforementioned proposed amendment shall be in favor thereof, then the proposed  
91   amendment shall be adopted and become a part of the Charter of Cecil County from and after  
92   the thirtieth day after said election.
