WHEREAS, Section 6-302 of the Tax-property Article, Annotated Code of Maryland requires the
governing body of each county to annually set the tax rate for the next taxable year; and

**WHEREAS**, Section 508 of the Charter of Cecil County requires that County Council shall levy the amount of taxes required by the Budget to ensure that the Budget is balanced so that proposed revenues equal proposed expenditures.

## NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, IN LEGISLATIVE SESSION, as follows:

- 1. That a County income tax for the taxable year beginning January 1, 2025, is hereby levied on all income stated on Maryland State income taxes shall be set at a rate of 2.74% on each dollar payable through the Maryland Comptroller;
- 2. That a County property tax for the taxable year beginning July 1, 2024 and ending June 30, 2025, is hereby levied and imposed on all assessments, income, or personal property subject to ordinary taxation in Cecil County;
- 3. That the rate of County taxation for such taxable year for real property is hereby fixed at \$0.9824 cents on each \$100 of assessed valuation of such property;
  - 4. That the rate of County taxation for such taxable year for personal property, as well as for operating real property (as described in Section 8-109(c) of the Tax Property Article, Annotated Code of Maryland) is hereby fixed at \$2.4560, which is 2.5000 times the rate as set forth above for real property;
  - 5. That the Winding Brook Special Taxing District property tax for the taxable year beginning July 1, 2024 and ending June 30, 2025, is hereby levied, and imposed on all parcels in the Special Taxing District at the rate of \$371.96 per parcel.
  - AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, that the County Executive and Director of Finance will cause the property tax to be collected in the manner provided by law.
  - AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, that the property and income tax rates shall be effective July 1, 2024 and shall continue in effect until changed under the laws of the State of Maryland and/or Cecil County.
