**CALL TO ORDER**

The meeting of the County Council of Cecil County of May 21, 2024, was called to order by Council President Gregory at 7:00 p.m.

**ROLL CALL**

Council Manager Culver called the roll and noted all five members were present.

President Gregory requested a moment of silence for retired USAF Colonel Henry "Hank" R. Passi who passed away on May 4, 2024.

**APPROVAL OF AGENDA**

### **CONSIDERATION OF RESOLUTIONS**

Council Manager Culver stated for the record:

Resolution 18-2024 - Grant Application – Community Development Block Grant – Child Advocacy Center Expansion

A Resolution to authorize the Cecil County Department of Community Services, Housing and Community Development Division, to apply for funding not to exceed \$723,000, from the Maryland Community Development Block Grant program through the Maryland Department of Housing and Community Development to renovate and expand the existing Child Advocacy Center to increase the provision of services to victims of child abuse and sexual assault and adult victims of domestic violence and their families. Grant funds will support construction costs associated with expanding the footprint of the Center and include roofing and generator costs and possible planning efforts and administrative support.

Introduced, read for the first time, order posted on April 16, 2024 and scheduled for consideration on May 21, 2024.

Director of Administration Steve Overbay noted that this grant application, if awarded, will help to expand the Child Advocacy Center.

Councilwoman Culberson made a motion to approve Resolution 18-2024, which was seconded by Councilman Miller.

The motion was approved 5 to 0.

### **NEW BUSINESS**

Cecil County Public Schools Budget Amendment #123

President Gregory noted that the Cecil County Public Schools Budget Amendment #123 is for \$1,023,903.


Councilman Miller made a motion to approve Budget Amendment #123 in the amount of \$1,023,903. The motion was seconded by Vice President Meffley. The motion was approved unanimously.
