**RESOLUTION NO. 29-2024**

**Title of Resolution:** Approval – Schneider Electric Multi-Year Contract

**Synopsis:** A Resolution to approve a two (2) year agreement between the County and Schneider Electric to manage the Decarbonization Project which includes maximizing energy and utility efficiency, and a plan for compliance with the Climate Solutions Now Act of 2020; giving the public high-profile advances in sustainable energy and technology for healthier environments for citizens and employees; updating neglected, aging facilities and systems; and modernizing technology and improving maintenance efficiency. The total value of the contract is not to exceed four (4) million dollars and is being funded by the VLT Fund, which is already approved by the Council.

1           **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2024, the County  
2 Executive submitted a proposed budget to the County Council for Fiscal Year 2025; and

3           **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held public  
4 hearings on the proposed budget submitted by the County Executive for Fiscal Year 2025; and

5           **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 4, 2024, the Budget  
6 for Cecil County was adopted for Fiscal Year 2025; and

7           **WHEREAS**, Cecil County will engage Schneider Electric to manage the Decarbonization Project; and

8           **WHEREAS**, Schneider Electric has agreed to a two-year agreement, not to exceed \$4,000,000, over  
9 the next two years, commencing in FY2025; and

10           **WHEREAS**, the proposed agreement is in excess of \$20,000.00 aggregate, and is for multiple fiscal  
11 years, for which County Council approval is required in accordance with Section 515(d) of the Cecil County  
12 Charter; and

13           **WHEREAS**, the County Executive now seeks County Council approval of the two (2) year agreement  
14 with Schneider Electric.

15           **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**  
16 **MARYLAND**, that the County Executive is authorized to enter a two (2) year agreement with Schneider  
17 Electric.

18           **AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND** that this  
19 Resolution shall take effect on the date of its passage by the County Council of Cecil County, Maryland.
