RESOLUTION NO. 28-2024 Appointment – Board of Library Trustees – Erin Dymowski and Jennifer Adams WHEREAS, pursuant to Section 23-401 of the Education Article of the Annotated Code of 1 Maryland, the county governing body may establish a county public library system free from political 2 3 influence; and WHEREAS, each county public library system shall be governed by a board of trustees; and 4 WHEREAS, pursuant to Section 23-403 of the Education Article of the Annotated Code of 5 Maryland, each Board of Library Trustees consists of seven members appointed by the county 6 governing body from nominees submitted by the Board of Library Trustees; and 7 WHEREAS, pursuant to Section 23-405 of the Education Article of the Annotated Code of 8 Maryland, each Board of Library Trustees has the powers and duties to establish and operate the 9 library, determine library policies, adopt rules, regulations and bylaws for the use of the library, 10 approve the library budget and spending of public funds and approve of the annual audit and annual 11 12 report; and WHEREAS, Article 4, Section 412 (b) of the Charter of Cecil County, except as provided in 13 Section 412(c) or prescribed by State law or other provisions, that the County Executive shall appoint 14 all members of boards and commissions and that such membership shall be subject to confirmation by 15 the Council; and 16 WHEREAS, the County Executive has recommended Erin Dymowski for appointment to the 17 Board of Library Trustees, completing the term of Tanya Area, which will expire on February 14, 2027, 18 and Jennifer Adams, replacing Steven Pearson, to a five-year term that will expire on February 28, 19 2029. 20 NOW THEREFORE, BE IT HEREBY RESOLVED THAT THE COUNTY COUNCIL OF CECIL COUNTY, 21 MARYLAND, confirms the recommendation by the County Executive of Erin Dymowski for appointment 22 to the Board of Library Trustees with a term to expire on February 14, 2027, and Jennifer Adams for 23 appointment to the Board of Library Trustees with a term to expire on February 28, 2029. 24

AND BE IT FURTHER RESOLVED that this Resolution shall take effect on the date of its passage by the County Council of Cecil County, Maryland.
