1	WHEREAS, in accordance with Section 505 of the Cecil County Charter, on April 1, 2024, the County
2	Executive submitted a proposed budget to the County Council for Fiscal Year 2025; and
3	WHEREAS, in accordance with Section 506 of the Cecil County Charter, the County Council held public
4	hearings on the proposed budget submitted by the County Executive for Fiscal Year 2025; and
5	WHEREAS, in accordance with Section 507(b) of the Cecil County Charter, on June 4, 2024 the Budget
6	for Cecil County was adopted for Fiscal Year 2025; and
7	WHEREAS, the County Executive is revising the Fiscal Year 2025 expense estimate for Cecil County to
8	increase use of the funds for the Board of Education budget by \$100,600 in order to allow the following
9	appropriations within the General Fund balance: the addition of \$100,600 for the completion of the Rising
10	Sun High School Water Line replacement. This project was budgeted in FY24 but was not completed in that
11	fiscal year, and;
12	WHEREAS, such appropriation is necessary to provide \$100,600 of the County Executives FY25 use of
13	County fund balance for said expenditures.
14	NOW THEREFORE, BE IT HEREBY RESOLVED that the Annual Budget and Appropriation Ordinance for
15	Cecil County, Maryland for Fiscal Year 2025 is hereby amended for the supplemental appropriation and by
16	amending the Current Budget to appropriate \$100,600 of County general fund balance to the Board of
17	Education.

19	County Council of Cecil County, Maryland.
