Supplemental Appropriation – Grant Funds – Office of Economic Development –  
Maryland Department of Commerce Grant and Maryland 5 Star Partial Matching Grant

1           **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2024, the County  
2 Executive submitted a proposed budget to the County Council for Fiscal Year 2025; and

3           **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held public  
4 hearings on the proposed budget submitted by the County Executive for Fiscal Year 2025; and

5           **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 4, 2024, the Budget  
6 for Cecil County was adopted for Fiscal Year 2025; and

7           **WHEREAS**, the County Executive is revising the Fiscal Year 2025 Special Revenue Other Grants Fund –  
8 Office of Economic Development revenue estimate for Cecil County to establish the following amount: the  
9 addition of \$75,000 in grant revenue and expense to the Special Revenue Other Grants Fund – Office of  
10 Economic Development budget to provide for the marketing of the Maryland 5 Star; and

11           **WHEREAS**, the Maryland 5 Star is an economic engine for the local and State economy; and

12           **WHEREAS**, the marketing will encourage visitation and drive economic impact to our region; and

13           **WHEREAS**, this grant will provide marketing, production, promotional support services for advertising,  
14 and diversity outreach for competitors; and

15           **WHEREAS**, such appropriation is necessary to provide \$75,000 in program funding for the Maryland 5  
16 Star, with a \$50,000 grant awarded from the Maryland Department of Commerce and with a \$25,000 grant  
17 awarded from the Maryland 5 Star to market and drive attendance through ticket sales. This grant will also  
18 encourage and drive the local and State economy and bring together many local and state partners to make the  
19 MD 5 Star happen.


20           **NOW THEREFORE, BE IT HEREBY RESOLVED** that the Annual Budget and Appropriation Ordinance for  
21 Cecil County, Maryland for Fiscal Year 2025 is hereby amended for the supplemental appropriation and by  
22 amending the Current Budget to appropriate \$75,000 in additional expenditures in the Special Revenue Other  
23 Grants Fund – Office of Economic Development to record the grant awarded from Maryland Department of  
24 Commerce to market and promote the Maryland 5 Star in Cecil County.

25           **AND BE IT FURTHER RESOLVED** that this Resolution shall take effect on the date of its passage by the  
26 County Council of Cecil County, Maryland.

#### SUMMARY OF LEGISLATION

**SPONSOR:** Council President at the request of the County Executive

**SYNOPSIS:** A resolution to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for the fiscal year ending June 30, 2025, in order to provide a total of \$75,000 to the Special Revenue Other Grants Fund - Office of Economic Development to record the \$50,000 grant awarded from the Maryland Department of Commerce and the \$25,000 grant awarded from the Maryland 5 Star.

**FISCAL IMPACT SUMMARY:** Net fiscal impact to the County will be \$0 (ZERO DOLLARS) for FY25. The grant award is providing all funding to the MD 5 Star Event.

---

**FISCAL ANALYSIS:** Net Fiscal Impact on the FY25 budget will be \$0. The Grant and matching contribution will raise revenue by \$75,000 and expenses by \$75,000. The additional Cecil County match of \$25,000 is already budget in the Tourism Department Advertising Account which was approved by Council on June 4, 2024.
