1           **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2015, the County  
2 Executive submitted a proposed budget to the County Council for Fiscal Year 2016; and

3           **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held  
4 public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2016; and,

5           **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 2, 2015, the  
6 County Council adopted the budget for Fiscal Year 2016; and

7           **WHEREAS**, the County Executive is revising the Fiscal Year 2016 Special Revenue – Other Grants  
8 Fund budget revenue estimate for Cecil County to establish the following amount:

- 9           a) The addition of \$1,843 in grant revenue and expense to the Cecil County Department of  
10           Emergency Services provided by the Local Government Insurance Trust (LGIT) to enable the  
11           County’s Emergency Planner to attend the 2016 National Hurricane Conference.

12           **WHEREAS**, such appropriation is necessary to provide \$1,843 of grant funding for the Special  
13 Revenue – Other Grants Fund for grant related expenses within the Cecil County Department of Emergency  
14 Services.

15           **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**  
16 **MARYLAND**, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for Fiscal  
17 Year 2016 is hereby amended for the supplemental appropriation and by amending the Current Budget to  
18 appropriate additional revenue and expenditures in the Special Revenue -Other Grants Fund to record the  
19 grant of \$1,843 awarded by LGIT to the Department of Emergency Services.

20           **AND BE IT FURTHER RESOLVED** that this Resolution shall take effect on the date of its passage by the  
21 County Council of Cecil County, Maryland.
