Chairman's Report – Mike Ratchford

 Hannah Allen, Director of Government Affairs, MD Chamber of Commerce to present legislative session update

Director's Report – Sandra Edwards for Bill Sorenson

- National Small Business Week support small businesses (shop, like on Facebook, etc.); social media posts
- Attending Ribbon Cuttings/Grand Openings
- Hosted Workshop at North East Library on Generative AI; help businesses with marketing use this tool

 saves time and money
- May 9 One-Day Patents Boot Camp; US Patents and Trademarks Office staff to present
 - Important for small businesses to protect their brand; protecting intellectual ideas
- May 14 One-Day Trademarks Book Camp; US Patents and Trademarks Office to present
- MD Economic Development Association (MEDA) Annual Conference in Cambridge last week
 - Great Wolf Lodge won Small Community Project for the year; Steve Jacobsen, Development Director, Chicago accepted award

Reminder - OED can run Placer reports for businesses

- Working on partnership program with Upper Shore Regional Council (USRC) and Cecil County Public Library on Video equipment loan program – more to come
- Galvinell devastating fire, est. \$2.5M in damages; OED offering assistance if needed
- 1st Ag Education Days 7th graders going to Fair Hill to learn about agriculture
 - Partnership between CCPS, Soil Conservation District, Extension Office, and OED

A Legislative Session Update was presented by Hannah Allen, Director of Government Affairs, MD Chamber of Commerce

- Legislative recap webinar now posted on YouTube
- Focus of Session:
 - MD Blueprint for Education w/price tag of billions
 - How to Fund how to raise revenue, what taxes/fees could be implemented
 - Other Revenue Needs: State's Transportation Trust Fund
- Fair Share for Maryland Act Bill proposals on businesses
 - Worldwide combined reporting the throwback rule (main focus)
 - Additional tasks on pass-through entities (typically small businesses)
- Update Sales Tax on Services Bill impact business-to-business services; expand tax to almost any service
 - Lower State Sales Tax from 6% to 5%
 - House wants to raise revenue with expanded sales tax on services, combined reporting, pass novel taxes, new fees; Senate held tight on no new taxes, no new business taxes
- Business Tax Structure no major changes
 - No one wants to raise taxes; governor doesn't want to raise taxes
 - How to fund commitments of Blueprint
- Transportation Fee Bills introduced as revenue for State's Transportation Trust Fund
 - Changes: new electric vehicle surcharge fee, adding new classification for weight-base registration for vehicles, transportation network company fee of \$.75/ride (fee on Ubers, lifts, etc. but does not supersede local fees), work-zone safety fees, increased dealer processing fee when buying new car
 - New transportation fees estimated to raise \$320M-\$350M over 3+ yrs.
- Consolidated Transportation Plan plan for revenue; current shortfall \$100M for FY2025 going to \$2B over 6-year cycle of plan
 - Train Commission to review/recommend transportation funding solution by end of year
- Data Privacy framework for regulating how consumers personal data is controlled, used, and processed
 - Pushed for alignment with other states mirroring definitions and enforcement
 - Change for Maryland for data minimization
- Paid Family and Medical Leave Insurance Program
 - Dept. of Labor made modifications, working on regulations
 - Implementation date delayed Contributions begin July 1, 2025 apply to employees and businesses w/15+ employees; Benefits can be drawn starting July 1, 2026
 - Employers can't self-insure and use private plan if opting out of State's plan
- Cannabis
 - Employer can no longer use currently accepted cannabis tests to determine if under influence;
 Testing capabilities and technologies not out yet no test like for alcohol
 - Concerns esp. for safety, sensitive positions (forklift, roofing)
- Wage Range Transparency in MD More to come
- Energy & Environment -
 - MD Dept. of Environment released Climate Pollution Production Plan recommendations to meet State's greenhouse gas reduction goals
 - Hazardous substance fee for transporting coal & natural gas
 - Cap and Invest Program statewide carbon tax
- Better Buildings Act mandates new residential or commercial construction meets electric-ready standards

A Legislative Session Update was presented by Hannah Allen, Director of Government Affairs, MD Chamber of Commerce

- High costs of construction; will be passed on to people buying and building (homes, buildings, commercial buildings, retail)
- Governor focused on affordable housing
- Non-Economic Damages Bill Removes cap on non-economic damages and civil actions for personal injury or wrongful death
- Economic Damages direct expenses of an accident (medical bills, lost wages, etc.)
- Non-Economic Damages intangibles (pain & suffering, physical impairment); cap \$935,000
- If cap had been increased, insurance premiums would increase 13-18% avg, auto liability 22-30% avg.
- Successful legislative session; over 2700 bills filed; big focus on revenue raisers to address budget deficit
- Key Bridge collapse demanded focus
- Items to Look at:
 - State permitting process streamline to make MD more competitive
 - Military Retirement Income Tax Exempting incentivize veterans to stay in MD
 - Spouses and children stay produce tax revenue

MD Dept. of Commerce – Brigitte Peters (message in chat)

- Link Governor's office looking for dozen private sector employers to participate in Service/Civic engagement related to Service Year Option Initiatives
- More Jobs for Maryland sun setting this year

Cecil College Update - Dr. Mary Bolt

- In Blueprint Great initiative funding 4-year colleges; Community Colleges squeezed; Governor cut \$122M from budget
- Community College supposed to educate and provide workforce training
- Can't fund two sectors of education and not fund the middle where many Marylanders' start jobs/careers
- Groundbreaking of Facilities new Entrance and Facilities Lead Building Project (started 2013); provide better safety for egress on campus, lead building for facilities, and some conference space
 - To be completed in 14 months
- May 19 Graduation; 230 students
