**Supplemental Appropriation – Grant Funds – Community Services –  
Community Development Block Grant – Child Advocacy Center Expansion**

1           **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2024, the  
2 County Executive submitted a proposed budget to the County Council for Fiscal Year 2025; and

3           **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held  
4 public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2025; and,

5           **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 4, 2024, the  
6 Budget for Cecil County was adopted for Fiscal Year 2025; and

7           **WHEREAS**, the County Executive is revising the Fiscal Year 2025 Emergency Shelter Grants fund  
8 revenue estimate for Cecil County to establish the following amount: the addition of \$672,000.00 in  
9 grant revenue and expense to the Department of Community Services, Housing and Community  
10 Development Division, Emergency Shelter Grants Fund budget, Fund 111, Department 534, to provide  
11 for a grant from the Maryland Department of Housing and Community Development, Community  
12 Development Block Grant Program; and

13           **WHEREAS**, such appropriation is necessary to provide \$672,000.00 in Community Development  
14 Block funding to support the Cecil County Child Advocacy Center Expansion Project; and

15           **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**  
16 **MARYLAND**, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for Fiscal  
17 Year 2024 is hereby amended for the supplemental appropriation; and by amending the current  
18 budget to appropriate \$672,000.00 to the Emergency Shelter Grant Fund, Fund 111, Department 534,  
19 to record the grant awarded from Maryland Department of Housing and Community Development,  
20 Community Development Block Grant funds, for the purpose of supporting the Cecil County Child  
21 Advocacy Center Expansion Project.

22           **AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that  
23 this Resolution shall take effect on the date of its passage by the County Council of Cecil County,  
24 Maryland.
