Supplemental Appropriation – Casino Local Impact Fund – Various Grants

1	WHEREAS, in accordance with Section 505 of the Cecil County Charter, on April 1, 2024, the County
2	Executive submitted a proposed budget to the County Council for Fiscal Year 2025; and
3	WHEREAS, in accordance with Section 506 of the Cecil County Charter, the County Council held public
4	hearings on the proposed budget submitted by the County Executive for Fiscal Year 2025; and
5	WHEREAS, in accordance with Section 507(b) of the Cecil County Charter, on June 4, 2024, the Budget
6	for Cecil County was adopted for Fiscal Year 2025; and
7	WHEREAS, the County Executive is revising the Fiscal Year 2025 Casino Local Impact Fund revenue
8	estimate for Cecil County to carry forward from fund balance within the Casino Local Impact Fund the following
9	amounts:
10	a) To carry forward \$15,000 in VLT grant funds awarded to the Conowingo Lions Club for expansion of
11	the Allred Community Center that was planned for FY24 but delayed due to final planning and zoning approval,
12	which has since been approved; and
13	b) To carry forward \$13,563.14 in VLT grant funds awarded to the Cecil County Community Mediation
14	Center due to delayed invoicing and accompanying time frames associated with reconciliation of expenditures of
15	grant funding; and
16	c) To carry forward \$3,973.00 awarded to Cecil College due to delayed invoicing and accompanying time
17	frames associated with reconciliation of expenditures of grant funding.
18	WHEREAS, such appropriation is necessary to provide \$32,536.14 of grant funding for the Casino Local
19	Impact Fund for grant related expenses within the VLT Local Community Grant Funds due to the full award being
20	unspent during the original grant period.
21	NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND,
22	that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for Fiscal Year 2025 is hereby
23	amended for the supplemental appropriation and by amending the Current Expense Budget to appropriate carry
24	forward of expenditure authority in the Casino Local Impact Fund in the amount of \$32,536.14.
