
Title of Resolution: Appointments—Emergency Medical Services Advisory Board

1 **WHEREAS**, pursuant to Chapter 34. Emergency Services, Department of; Section 34-4. Emergency
2 Medical Services of the Code of Cecil County, the Emergency Medical Services Advisory Board provides
3 oversight of Cecil County’s career EMS Supplement Services; and

4 **WHEREAS**, pursuant to Chapter 16. Boards, Committees, and Commissions; Section Article V.
5 Emergency Medical Services Advisory Board, the Board provides oversight of Cecil County’s career EMS
6 Supplement Services, which are supported by the Department of Emergency Services; and

7 **WHEREAS**, the Board shall function as an advisory role and render recommendations to the
8 County Administration through the Director of Emergency Services on operational issues, which will
9 sustain the career/volunteer relationship that renders the best delivery of Emergency Medical Services to
10 meet the needs of Cecil County; and

11 **WHEREAS**, the Board consists of fifteen (15) voting members, which include nine (9) members
12 representing the nine-volunteer fire/EMS companies; five (5) members representing each of the five
13 councilmanic districts; and one (1) member representing the IAFF Local; and three (3) non-voting
14 Ex-Officio members that include the Director of the Department of Emergency Services; Local Physician
15 EMS Medical Director; and one (1) representative of the Cecil County Firemen’s Association; and

16 **WHEREAS**, Article 4, Section 412 (b) of the Charter of Cecil County provides, except as provided in
17 Section 412(c) or prescribed by State law or other provisions, that the County Executive shall appoint all
18 members of boards and commissions and that such membership shall be subject to confirmation by the
19 Council; and

20 **WHEREAS**, the Board shall continue to serve until their reappointment or until the successors are
21 appointed; and

22 **WHEREAS**, the Board vacancies, except those at the expiration of a term, shall be filled in the same
23 manner as the original appointments and for the rest of the unexpired term; and

24 **WHEREAS**, the County Executive is recommending the following members to the Emergency
25 Medical Services Advisory Board for a three (3) year term, which is to expire on June 1, 2027:
