
Supplemental Appropriation – Grant Funds – Community Services – Cecil
Transit Division – Statewide Special Transportation Assistance Program

1 **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2024, the
2 County Executive submitted a proposed budget to the County Council for Fiscal Year 2025; and
3 **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held
4 public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2025; and,
5 **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 4, 2024, the
6 Budget for Cecil County was adopted for Fiscal Year 2025; and
7 **WHEREAS**, the County Executive is revising the Fiscal Year 2025 Community Services Grants
8 Fund – Department of Community Services – Cecil Transit Division, Fund 109, Department 522, revenue
9 estimate for Cecil County to establish the following amount: the addition of \$272,356.00 in grant
10 revenue and expense to the Community Services Grants Fund – Department of Community Services
11 budget to provide for a Statewide Special Transportation Assistance Program grant from the Maryland
12 Transit Administration; and
13 **WHEREAS**, such appropriation is necessary to provide \$272,356.00 in grant funding for capital
14 expenditures; and
15 **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**
16 **MARYLAND**, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for Fiscal
17 Year 2025 is hereby amended for the supplemental appropriation and by amending the Current Budget
18 to appropriate \$272,356.00 of additional expenditures in the Community Services Grants Fund –
19 Department of Community Services, Fund 109, Department 522, to record the grant awarded from the
20 Maryland Transit Administration.
21 **AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that
22 this Resolution shall take effect on the date of its passage by the County Council of Cecil County,
23 Maryland.
