Appointment—Planning Commission- Christopher Walker, Robb Carey,  
and Chistopher Bannon II

1           **WHEREAS**, a local jurisdiction may establish by local law a planning commission with the powers and  
2 duties set forth in this division, pursuant to Section 2-101 in the Land Use Article of the Annotated Code of  
3 Maryland; and,

4           **WHEREAS**, the Cecil County Planning Commission was established and consists of six members plus  
5 an alternate who shall serve in the absence of a regular member; and a member of the County Council who  
6 serves as an ex-officio, non-voting member; pursuant to Section 295; Article XVI, of the Cecil County Zoning  
7 Ordinance; and,

8           **WHEREAS**, each Planning Commission member serve three-year terms and must be a resident of  
9 Cecil County; and,

10           **WHEREAS**, the duties of the Planning Commission are to review, evaluate, and approve or disapprove  
11 plans for subdivisions in according with the Zoning Ordinance and Subdivision Regulations; and to review and  
12 make recommendations to the Cecil County Council regarding proposed changes or amendments to the  
13 Comprehensive Plan, Chesapeake Bay Critical Area Program, Zoning Ordinance, Subdivision regulations, Road  
14 Code, Master Water and Sewer Plan, acquisition and development of lands for open space or recreation  
15 purposes, historic sites or districts, land use or development arising from state or federal programs or  
16 policies, Forest Conservation Regulations; and to review the Capital Improvement Program annually; and to  
17 make recommendations to the Board of Appeals regarding applications for special exceptions; and,

18           **WHEREAS**, Article 4, Section 412 (b) of the Charter of Cecil County provides, except as provided in  
19 Section 412(c) or prescribed by State law or other provisions, that the County Executive shall appoint all  
20 members of boards and commissions, subject to confirmation by the Council; and,

21           **WHEREAS**, The County Executive approves the appointment of Christopher Walker who is replacing  
22 Christopher Bannon II with a term to expire on August 17, 2027, Robb Carey with a term to expire on July 21,  
23 2026, and Christopher Bannon II to replace James Perry as the alternate with a term to expire August 17,  
24 2027 to the Cecil County Planning Commission.

25           **NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**  
26 **MARYLAND**, that the County Council of Cecil County confirms the appointment of Christopher Walker with a  
27 term to expire on August 17, 2027, and Robb Carey with a term to expire on July 21, 2026, and Christopher  
28 Bannon II as the alternate with a term to expire August 17, 2027 to the Cecil County Planning Commission.
