2	agency shall establish an advisory council that shall carry out advisory functions which further
3	the area agency's mission of developing and coordinating community-based systems of services
4	for all older persons in the planning and service area, and
5	WHEREAS, Pursuant to Section 1321.57(b) of the Older Americans Act of 1965, the
6	council shall include individuals and representatives of community organizations who will help
7	to enhance the leadership role of the area agency in developing community-based systems of
8	service; and
9	WHEREAS, Pursuant to Chapter 10 Human Services, Section 201 of the Annotated Code
10	of Maryland, the Maryland Department of Aging was created as a principal executive
11	department to administer programs mandated by the federal government throughout the state
12	through the Area Agencies on Aging;
13	WHEREAS, the Maryland Department of Aging has designated the Senior Services and
14	Community Transit of Cecil County as the Area Agency on Aging; and
15	WHEREAS, the Cecil County Commission on Aging oversees the provision of services to
16	seniors as the advisory council to the Area Agency on Aging in Cecil County; and
17	WHEREAS, the Commission on Aging identifies, assesses, and advocates for the needs of
18	the growing older adult population in Cecil County; encourages the development of services
19	designed to address those needs; and supports the mission of the Senior Services and
20	Community Transit of Cecil County of developing and coordinating community-based systems
21	of services for all older adults in County; and
22	WHEREAS, Pursuant to Section 412(b) of the Charter of Cecil County, the Executive shall
23	appoint all members of boards and commissions and that such membership shall be subject to
24	confirmation by the Council; and
25	WHEREAS, the County Executive approves the appointment of Jamie McCloskey,
26	representative of the Cecil County Public Library, to fill the vacancy of Leah Youse to the Cecil
27	County Commission on Aging.
