4	currently open for the delivery of waste between the hours of 7:30 a.m. and 3:30 p.m., Monday through
5	Saturday.
6	NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, IN
7	LEGISLATIVE SESSION
8	That Section 318-4 of the Cecil County Code (Days and Hours of Operation of Disposal Facilities) is
9	amended as follows:
10	A. The Cecil County Central Landfill will be open for the delivery of waste between the hours of
11	7:30 a.m. and 3:30 p.m., Monday through FRIDAY Saturday AND 8:00 A.M. AND 11:30 A.M. ON
12	SATURDAY.
13	AND BE IT FURTHER REVOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, IN
14	<b>LEGISLATIVE SESSION</b> that the revised days and hours of operation shall be effective July 1, 2016 and shall
15	continue in effect until changed under the laws of the State of Maryland and/or Cecil County.
