## **INFORMATIONAL ITEMS**

• User Fees - Per Director Van Dyke, Cecil County Public Schools is proposing an increase in user fees beginning in the 2015 school cycle. Cecil County Parks and Recreation will need to revisit their current fee schedule if CCPS follows through with these proposed fees. It is anticipated that CCPS user groups will be coming over to Cecil County Parks and Recreation due to lower fees. Executive Moore and Director Van Dyke have discussed user fees over the past 4-6 weeks and Executive Moore has also discussed fees with Dr. Devine of CCPS. Executive Moore feels the CCPS user fee announcement may create a much higher need for CCPR fields and she would like to everyone to consider the future of CCPR and its fields. Executive Moore also stated Director Van Dyke and the department have set a high standard as far as care and maintenance of their fields. She feels CCPR can offer some of the best fields in the region and wants to remain consistent in their quality. A suggestion was made for teams using CCPR fields to possibly hold fundraisers or use advertising on fences to generate funds. Executive Moore asked the Parks Board to think about what it wanted for CCPR's as we look toward the future. User fees for CCPS as well as CCPR will continue to be discussed. Partnerships with CCPS are also being discussed. CCPR will continue to work on fee comparisons with other MD counties.

 501c3 – Mario discussed document changes with County Attorney, Jason Allison. Director Van Dyke will be the Ex-Officio of the 501c3. Mario is working on the application for the 501c3. This document will need to be typed.
