INFORMATIONAL ITEMS

 Welcome Joe Harbert: Introductions; The need for Parks and Recreation and CCPS to work together to serve the community was discussed.

Update Calvert Regional Park: Per Director Van Dyke, the final signatures should be in this week for the earth work
and the RFP should go out next week. The progression of work will be grading for Phase I, the synthetic turf field,
the parking lot, the natural grass fields, and the trail. We are hoping to break ground the first week of November.
 For the synthetic turf we will be riding off of an E & I contract.

Update Elk River DMP: Per Director Van Dyke, the bid was awarded to Reybold Construction, LLC for \$530,000. The
scope was reduced from 70,000 cubic yards to 56,000 cubic yards based on our Water Way Improvement funding
from the State of MD. The project will take approximately 4 months to complete. Bayland Consultants and
Designers, LLC will provide inspection services. On another note regarding the Elk River site, an amendment to our
current park ordinance is under review by our County Attorney regarding the transport of unloaded weapons from
vehicles to boats for hunting offshore.

• User Fees: The department is waiting to see the final draft from CCPS regarding user fees. Director Van Dyke has asked to be included in future meetings with CCPS regarding user fees.

Update 501c3: Per Mario Gangemi, the Articles of Incorporation are back. The Bylaws are in the final draft. The
application is done, but there are a few accounting questions that will be discussed with Jason. A CPA may be
needed to answer these questions. The Employer Identification Number has been established. Mario met with
Tracy Bauguess and Don Harmer to discuss fundraising efforts and a pre-capital campaign plan.
