

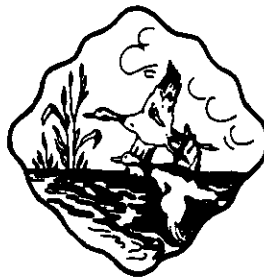

Re: Local Drug & Alcohol Abuse Council

Dear Governor Ehrlich:

We are writing in reference to the provisions of Chapters 237 and 238 of the Laws of 2004, and the requirement of each local sub division creating Local Drug and Alcohol Abuse Councils (new Subtitle 10, Title 8, Health-General Article).

Pursuant to the law, we desire to designate our existing community health "Alcohol and Drug Task Force" to implement the provisions of the law. Additionally, we propose to include the other individuals stated in 8-1001 (C) Health-General, who are not members of the existing task force.

During the initial organizational process of the new Council it would be beneficial for the Council to have the appropriate State staff present further detail relating to implementation and funding issues relating to this effort.

The Board of Cecil County Commissioners voted in public session at their September 7, 2004 meeting and unanimously approved this designation.

We have enclosed a document which reflects the existing and proposed new membership in accordance with the law.
