1           **WHEREAS**, Section 214 of the County Charter requires that the County Council shall appoint by  
2 resolution a Redistricting Commission not later than April 1, of the year following each decennial census  
3 date; and

4           **WHEREAS**, the County Council shall appoint all such nominees as members of the Commission as  
5 well as one or two additional members of the Commission, as the case may be, to ensure that its total  
6 membership equals an odd number; and

7           **WHEREAS**, the County Council shall appoint the Chair of the commission from among the  
8 Commission members; and

9           **WHEREAS**, the County Council approved of Resolution No. 10-2013 on March 19, 2013, which  
10 named William Harris as chair of the Redistricting Commission; and

11           **WHEREAS**, Mr. Harris indicated on April 11, 2013, that he was unable to serve as the chair and  
12 that, as such, he was resigning the chair; and

13           **WHEREAS**, the Council is now resolved to appoint C. Ewing McDowell as successor to Mr. Harris, to  
14 serve as chair of the Redistricting Commission.

16           **NOW, THEREFORE, BE IT HEREBY RESOLVED** by the County Council of Cecil County, Maryland, that  
17 C. Ewing McDowell is appointed to chair the Redistricting Commission;
