2 the authority conferred by it and its authorized officers according to Section 411 of the Cecil County  
3 Charter, and Maryland law, such attorneys to act under the title of special counsel to the County  
4 Attorney, to provide legal advice and to represent the County in matters that may be pending or that  
5 may hereafter be instituted before any court of administrative agencies and departments of  
6 government brought by or against the County, and in matters in which the County has a legal  
7 interest; and,

8           **WHEREAS**, the County Attorney has now requested, pursuant to Section 411 of the Cecil  
9 County Charter, the following appointments as special counsel for Fiscal Year 2014:

10           (1) Cameron Brown, Esquire, Clara Campbell, LLC, to serve as legal counsel to the Cecil County  
11           Board of Zoning Appeals;

12           (2) Clara Campbell, Esquire, Clara Campbell, LLC to serve as legal counsel to the Cecil County  
13           Planning Commission for Fiscal Year 2014; and,

14           (3) Clara Campbell, Esquire, Clara Campbell, LLC, to serve as legal counsel to the Cecil  
15           County Department of Planning and Zoning and Department of Permits and Inspections,  
16           respectively, in Code enforcement litigation; and

17           **WHEREAS**, the Council is now resolved to appoint Cameron Brown, Esquire, Clara Campbell,  
18           LLC, to serve as legal counsel to the Cecil County Board of Zoning Appeals for Fiscal Year 2014, Clara  
19           Campbell, Esquire, Clara Campbell, LLC to serve as legal counsel to the Cecil County Planning  
20           Commission for Fiscal Year 2014, and Clara Campbell, Esquire, Clara Campbell, LLC, to serve as legal  
21           counsel to the Cecil County Department of Planning and Zoning and Department of Permits and  
22           Inspections, respectively, in Code enforcement litigation for Fiscal Year 2014, at the rate of \$80.00  
23           per hour.

24           **NOW, THEREFORE, BE IT HEREBY RESOLVED** by the County Council of Cecil County, Maryland,  
25           that Cameron Brown, Esquire, Clara Campbell, LLC, is hereby appointed to serve as legal counsel to the Cecil  
26           County Board of Zoning Appeals for Fiscal Year 2014 at the rate of \$80.00 per hour; and,

27           **BE IT FURTHER RESOLVED** by the County Council of Cecil County, Maryland, that Clara  
28           Campbell, Esquire, Clara Campbell, LLC, is hereby appointed to serve as legal counsel to the Cecil County  
29           Planning Commission for Fiscal Year 2014 at the rate of \$80.00 per hour; and,

30 **BE IT FURTHER RESOLVED** by the County Council of Cecil County, Maryland, that Clara  
31 Campbell, Esquire, Clara Campbell, LLC, is hereby appointed to serve as legal counsel to the Cecil  
32 County Department of Planning and Zoning, and as legal counsel to the Cecil County Department of Permits  
33 and Inspections, respectively, in Code enforcement litigation for Fiscal Year 2014, at the rate of \$80.00 per  
34 hour.
