WHEREAS, on July 14, 1995, the Board of County Commissioners of Cecil County (now, Cecil County, Maryland) (hereinafter, the "County") made a loan to Moon Nurseries, Inc., a Maryland corporation (formerly known as Moon Nurseries of Maryland, Inc.) (hereinafter, the "Borrower"), in the original principal amount of \$1,200,000 (the "Loan"); and,

**WHEREAS,** the Loan is evidenced by a Promissory Note dated July 14, 1995 made by the Borrower for the benefit of the County (the "Note"); and,

WHEREAS, the terms of the Loan are governed by a Loan Agreement dated July 14, 1995 between the Borrower and the County (the "Loan Agreement"); and,

WHEREAS, repayment of the Loan is secured by a lien on the Borrower's facility located in Cecil County, Maryland (the "Facility") under the terms of a Deed of Trust and Security Agreement dated July 14, 1995, made by the Borrower to Keith A. Baynes, Esquire, as trustee for the benefit of the County and recorded in the Land Records of Cecil County, Maryland in Liber 0550, page 065 (the "Deed of Trust"); the Note, the Loan Agreement, the Deed of Trust, and all other documents executed in connection with the Loan, as any of them may be amended, are collectively referred to as the "Loan Documents"; and,

WHEREAS, from July 14, 1995, the County received repayments of the Loan; and,

WHEREAS, on March 21, 2000, pursuant to a letter from the State of Maryland Department of Community Development (hereinafter, the "Department") to the County, as revised pursuant to a letter dated March 22, 2001, the County was advised that repayments of the Loan would be collected by a loan servicing agent; and,

**WHEREAS,** since March 21, 2000, the County is without knowledge of collection, receipt, distribution, or other actions taken pursuant to this arrangement; and,

WHEREAS, as provided in the Assignment, the County desires to assign the Loan Documents to the Department and to endorse and assign to the Department the Loan and the Loan Documents (defined as the Note, the Loan Agreement, the Deed of Trust, a Corporate Guaranty Agreement, an Affidavit of Lost Promissory Note, and a First Modification to Loan Agreement and First Promissory Note Modification Agreement, and the Department has agreed to accept the assignment of all of the County's rights in connection with the Loan, including the Loan Documents, upon approval of the transaction by the County Council.
