REQUEST FOR OUTDOOR SALES Request received from Kevin Morgan; Frank Broomall; John Giordano; Stripers LLC, T/A Schaefer's Restaurant, 208 Bank Street, Chesapeake City, MD 21915 Frank Broomall appeared before the Board requesting permission for outdoor sales – he stated they have a permanent bar outside but would like to have a service bar for servers to utilize to make it easier and quicker for customer service. The Board asked about the Banquet hall and he stated they are applying for permits, etc at this time.
