1	WHEREAS, Division I, Title 8, Subtitle 1, §8-104 et seq. of the Land Use Article, Annotated Code
2	of Maryland authorizes the County to establish regulations and procedures to designate a property as a
3	historic district; and
4	WHEREAS, Article XI, Part IV, Historic District of the Cecil County Zoning Ordinance provides the
5	regulations and procedures to preserve historic districts, landmarks, sites, or structures of historical,
6	archeological, or architectural significance, with their appurtenances and environmental settings, for the
7	public welfare of the residents of Cecil County: and
8	WHEREAS, the owners of record, Cecil County Government, submitted a nomination form and
9	supporting documentation to establish a historic district for the property at 1221 Calvert Road, Rising Sun,
10	MD, District 9, Tax Map 11, Parcel 396 known as Cross Keys Tavern; and
11	WHEREAS, the establishment of a historic district has been proposed and on October 7,
12	2014, the Historic Commission held a public hearing and has recommended approval of the historic
13	designation for Cross Keys Tavern; and
14	WHEREAS, on October 17, 2014, the Planning Commission held a public hearing and has
15	recommended approval of the historic designation for Cross Keys Tavern.
16	NOW, THEREFORE, BE IT HEREBY RESOLVED by the County Council of Cecil County, Maryland,
17	that the property located at 1221 Calvert Road, Rising Sun, MD, District 9, Tax Map 11, Parcel 396 known
18	as Cross Keys Tavern is designated a historic district and shall be added to the Cecil County Register of
19	Historic Places; and
20	AND, BE IT FURTHER RESOLVED that this Resolution shall take effect on the date of its passage by
21	the County Council of Cecil County, Maryland.
