Budget Amendment - Grant Budget - Sheriff's Office WHEREAS, in accordance with Section 505 of the Cecil County Charter, on March 1, 2014, the 1 2 County Executive submitted a proposed budget to the County Council for Fiscal Year 2015; and 3 WHEREAS, in accordance with Section 506 of the Cecil County Charter, the County Council held public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2015; and 4 5 WHEREAS, in accordance with Section 507(b) of the Cecil County Charter, on May 20, 2014, the County Council adopted the budget for Fiscal Year 2015; and 6 7 WHEREAS, the County Executive is revising the Fiscal Year 2015 General Fund Budget Cecil County 8 to establish the addition of \$9,936 in grant revenue and expense within the the General Fund for the Cecil 9 County Sheriff's Office from the United States Department of Justice Organized Crime Drug Enforcement 10 Task Force.
