1	<b>WHEREAS,</b> in accordance with Section 505 of the Cecil County Charter, on March 1, 2014, the
2	County Executive submitted a proposed budget to the County Council for Fiscal Year 2015; and
3	WHEREAS, in accordance with Section 506 of the Cecil County Charter, the County Council held
4	public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2015; and
5	WHEREAS, in accordance with Section 507(b) of the Cecil County Charter, on May 20, 2014, the
6	County Council adopted the budget for Fiscal Year 2015; and
7	WHEREAS, the County Executive is revising the Fiscal Year 2015 General Fund revenue estimate for
8	Cecil County to increase the amount of fund balance by \$1,774, consisting of carryover unspent revenues
9	from the 2014 Volunteer Recognition Event, and private donations in the current year of \$1,226.
10	NOW THEREFORE, BE IT HEREBY RESOLVED that the Annual Budget and Appropriation Ordinance
11	for Cecil County, Maryland for Fiscal Year 2015 is hereby amended for the supplemental appropriation and
12	by amending the Current Expense Budget to appropriate \$3,000 of additional expenditures of the General
13	Fund to increase the County Administration department for the 2015 Volunteer Recognition Event.
